***A. Solving the Transmission Challenge for Decarbonization***

Transmission development is increasingly identified as necessary to meet climate and clean energy goals and to ensure that the region can weather the clean energy transition and remain resilient. However, issues such as where to site and how to pay for new transmission continue to create barriers. As the ISO's 2050 Transmission Study is finalized, FERC has issued a NOPR on transmission and DOE launches a new effort on transmission planning. Can these efforts help to break the logjam in our region? Discussion topics will include: How do we build more transmission outside of the traditional "need" and reliability frameworks? Who should pay for transmission? Can public support for new transmission be increased? Are we using our existing resources to their full potential? What can we learn from recently proposed projects?

***A. Gas in a Net Zero World***

Reaching Net Zero by 2050 requires momentous changes in the way we heat and power our economy. New England is on the cutting edge of developing a road map to achieve net zero on the thermal side, but how do we realistically achieve this ambitious goal as quickly as the climate crisis requires? ***B. Closing the Gaps in Broadband Adoption***

During the pandemic, the depth of the digital divide was revealed. To address gaps in broadband access and use, many are focused on “digital inclusion” – efforts focused on serving disadvantaged, unconnected community members through several approaches: affordable internet access, affordable devices, digital literacy training, and access to ongoing support. To implement these goals, programs such as the Affordable Connectivity Program have been created to provide access to eligible populations.
